'Hindu Pramān' Logo Usage Agreement

By signing the following 'Hindu Pramān' Certification Agreement, the Manufacturer and or Processor who seeks 'Hindu Pramān' Certification for his products and or brands agrees to comply, agree and abide by all the terms and conditions of certification as mentioned below. Any violation observed or reported shall result into immediate suspension or withdrawal of the 'Hindu Pramān' Certification.

- Declares that none of the products manufactured or processed contains any animal ingredients in any form as stated in the standard 'Hindu Pramān'-Requirement (HFC 22015) including its ingredients, additives and their process sources as mentioned. And that all the information provided is true and correct.
- If required, shall allow the certification body to inspect the premises for them to verify compliance to this standard at any time while holding a valid certificate. Such visits shall NOT be pre-notified. Upon finding any non-compliances, IHPC reserves all rights to withdraw or suspend the certificate with immediate effect.
- That whatsoever information has been submitted to IHPC during application and later as part of evidence for compliance is true and correct to the best of our knowledge and belief.
- Shall immediately intimate to IHPC on any changes or modifications to certified products, brands, their processes, ingredients, additives, processing aids and/or packing material which could affect integrity of violating Hindu Pramān Certification Standard and amendments thereafter while holding a valid certificate.
- When asked for any clarification, shall report with further information or clarification as needed.
- Shall handover the original certificate to IHPC, after its expiry or suspension or withdrawal.
- Shall follow all the terms and conditions stated in the usage of the logo on any media, campaigns, or product packing material. Agree not to violate any of the terms and conditions which may lead to immediate withdrawal or suspension of the 'Hindu Pramān' Certificate.
- Agree to pay the fees as applicable before the certificate is issued.
- Agree to get the product(s) or any of its ingredients or additives tested in an IHPC approved or credible laboratory as required and produce the genuine certificate(s) indicating the test results.
- Agree not to mislead or misguide or provide false or incorrect information to IHPC in declaring or furnishing any required information or information as asked for.
- Agree to accept immediate suspension or withdrawal of certification, in case any non-compliance is observed or reported by the IHPC inspection authorities during inspection and shall follow all steps mandated by the authorities without any objection or resistance.
- Agree that the certification shall be put on suspension or withdrawn by the IHPC if any negative report related to the certified product(s) or manufacturing / processing company is published on any mass media including newspaper, internet or television.
- Agree that the certification shall be put on suspension by the IHPC if any customer reports a serious lapse in the manufacturer's / processor's declaration of ingredients in a product for it containing any non-permitted items.
